An Example of IB Commission Reward Calculation

For example, you attracted 5 clients with a deposit \$1000



Within a month, three of them have made deals via NetTradeX on the EURUSD with the volume of 4,000,000 base currency units each, and the other two have made deals via MetaTrader 4 on CFD for SP500 with the volume of 25 lots each.



NetTradeX

4 000 000 (EURUSD) + 4 000 000 (EURUSD) + 4 000 000 (EURUSD)

MetaTrader 4

25 Lots (SP500) + 25 Lots (SP500)

Your commission in the NetTradeX will be:

$4.000.000 / 100.000 \times$
 $\times \$10$ (commission in the NetTradeX) \times
 $\times 3$ (number of clients)
 $= \$1200$

Your commission in the MetaTrader 4 will be:

$25 \text{ Lots} \times$
 $\times \$9$ (commission in the MT4) \times
 $\times 2$ (number of clients)
 $= \$450$

As a result, your earned commission within the billing month will be

1650 

for 5 attracted clients.
